Sub: Treating of technical break period in between two ad-hoc spells in the grade of STS of officers belonging to Accounts and Finance service, for the purpose of financial upgradation - regarding.

The undersigned is directed to draw your kind attention to Sub-para 3 under Para-I(d) of the Personnel branch, CO BSNL letter no. 400-61/2004-Pers.I dated 18.01.2007 alongwith clarification at Sl. 4 in Pers. Branch, CO BSNL Lr No. 400-29/2007-Pers-I dated 30.05.2007 on the subject mentioned above and to convey the approval of Cadre Controlling Authority in CO BSNL for treating the break period between two ad-hoc spells in the grade of STS of Accounts and Finance Service i.e. from 04.02.2004 to 17.08.2004, or the date of assumption of charge by the officer, based on the instructions issued vide this office letter no. 2-30/2002-SEA-BSNL dated 18.08.2004, as technical break, so as to enable BSNL to implement the time bound financial upgradation.
