Subject: Postponement of programme of organizational actions as notified vide our letter No. AIBSNLEA/CHQ/Notice/2007-08/229 dated 7-5-2007.

Sir,

Kindly recall our discussion with you on 11-6-2007 regarding the grievances of the officers members of this association. We are thankful for the keen interest that you have shown in this respect. In the meeting you assured that in consultation with Director (HRD) suitable actions will be taken to pave the way to sort out the ticklish problems associated with the new Executive Promotion Policy and other issues of importance.

In this regard we would also like to inform you that we had an informal meeting with the Secretary DoT on 1-6-2007 in this respect. As advised by him, we have already addressed a letter vide No AIBSNLEA/CHQ/TC/2007-08 Dated 4th June, 2007 to Secretary DoT and copy endorsed to you under lining the necessity for the early settlement of the issues. We were assured by Secretary DoT that we shall be granted a formal meeting in presence of BSNL Management to discuss those issues immediately on his return from the tour abroad, perhaps in the first week of July-07. This may be helpful to sort out the issues identified as "Under the purview of DoT".

In view of all those stated above as well as the renewed appeal by Director (HRD) & DDG(SR) BSNL as contained in letter No BSNL/31-3/SR/2007 dated 11-6-2007, it is now decided to postpone with immediate effect the ongoing programmes of protest actions. We have also conveyed your advice to our member officers not to resort to the agitation at this stage and to devote the full energy and mind in the services to the customers. We hope this will generate more congenial atmosphere and goodwill to sort out the contentious issues.

However, our Central Working Committee is going to meet on 26th and 27th July, 2007 at Faridabad (Haryana). Our Central Working Committee is likely to review the entire situation and status of the implementation of the assurances given recently and decide further appropriate action in this respect.
